Register as a **Single Selling Scout** with Patriots' Path Council and participate in **Storefront, Wagon and Online Sales.**

Here's how it works:

- 1) We will create an account for you in the Trail's End Popcorn system. Your earnings can be used toward uniform parts & supplies, your troop trips, summer camp or high adventure trips, Patriots' Path Council organized NYLT or other youth training and OA.
- 2) Participate in the Store Front Sale (8/2 - 10/28), Online Sale (8/1 - 12/31) and the Wagon Sale (8/2 - 10/28).
- 3) Place your order(s) using the Trail's End webpage by July 14th or any of the other 2025 order dates.
- 4) Pick up your popcorn orders on the morning of August 2nd or any of the other 2025 pick-up dates at the designated locations.
- 5) Sell the popcorn using the Trail's End App at a storefront, wagon sale or online.
- 6) Have your commission deposited directly into your bank account (if you set your account up in Trail's End).

2% Commission by Preparing:

- A single seller kernel attends a ZOOM Required Council training session.
The Trail's End training courses do not count.

Up To 6% Commission for achieving Sales Success:

Increase your 2024 Sale[^]:

- 5% Increase over your 2024[^] sales = additional 2% commission
- 10% Increase over your 2024[^] sales = additional 4% commission
- 15% Increase over your 2024[^] sales = additional 6% commission

[^] If the Scout did not have sales in 2024 than they will use the 2024 council average of \$542 per Scout.
